WHEREAS in terms of section 15(1) of the NCTE Act, 1993 Faculty of Education, Gyan Mahavidyalaya, Agra Road, Aligarh- 202001, Uttar Pradesh had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for starting B.T.C. Course of One year duration with an annual intake of 50 (Fifty Only) students on 30.01.2004.

AND WHEREAS, the Inspection of said Institution was conducted on 08.12.2005.

AND WHEREAS, on scrutiny perusal of the application submitted by the institution, the documents attached therewith, the affidavit, input received from the visiting team in the form of report/ videography and the input received from, recommendation of the State Government, the Northern Regional Committee in its 104th Meeting held from 15th and 17th July, 2006 decided that show cause notice under section 15(3)(b) of NCTE, Act. 1993 be issued to the institution, as per session show cause notice dated 13.01.2006 was issued to the Institution.

AND WHEREAS, the reply of show cause notice submitted by the Institution was considered by the NRC in its 101st meeting and as per decision letter dated 17.04.2006 was issued to the Institution to seek information on the certain points. The matter was again considered by NRC in its 104th meeting and as per decision letter of conditional recognition dated 26.07.2006 was issued to the Institution.

AND WHEREAS, the matter was placed before NRC in its 141st Meeting held from 22nd to 24th May, 2009 & as per the decision of NRC, recognition was refused vide order dated 24.07.2009.

AND WHEREAS the above said Institution, thereafter preferred an appeal before the Council under section 18 of the NCTE Act, 1993 against the aforesaid order of NRC and the case was remanded back to NRC by the Council vide order dated 05.03.2010. The matter was placed before NRC in its 157th meeting held from 24th to 27th March, 2010 & as per decision of NRC, the Institution was directed to appoint the faculty through duly constituted selection committee comprising of subject expert nominated by the affiliating body within three months vide letter dated 13.04.2010.

AND WHEREAS, the reply of the institution received in the office of NRC on 05/07/2010 was considered by NRC in its Emergency Meeting held on 19 July, 2010 and committee decided that recognition for B.T.C. Course under clause 7(11) of NCTE Regulation, 2007 be granted to the Institution.

NOW, THEREFORE, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to Faculty of Education, Gyan Mahavidyalaya, Agra Road, Aligarh- 202001, Uttar Pradesh for conducting B.T.C. One year Course with an annual intake of 50 (Fifty Only) students from the academic session 2010-2011 under clause 7(11) of NCTE Regulations subject to the following conditions as per decision taken in 166th meeting.

- The admission of the students shall be completed well before the cut off date prescribed by the examining body for admission to the academic session 2010-2011, failing which admission for additional seats shall be given from the academic session 2011-2012.
- Formal recognition / permission will operate for 2010-2011 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University/affiliating body failing which the recognition will be effective from the academic session 2011-2012.
- The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.
- The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

- v) The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2009.

Further, the recognition/permission is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.

The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.

The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -

- Copy of the Application Form
- Land and Building Particulars
- Staff Profile
- Recognition letter
- Information for having fulfilled the norms & standard and other required conditions.

In case if the land is in the name of the Society, you must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.

If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and orders made or issued, there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act 1993
